## CALLING NOTICE: EXPRESSIONS OF INTEREST ROUTESETTERS AND OFFICIALS OCEANIA CHAMPIONSHIPS SYDNEY 2020

OCSC is seeking expressions of interest for the following positions at the Oceania Continental Championships to be held at Villawood Climbing Centre Unit 5/850 Woodville Rd, Villawood, Sydney NSW 2163, Australia, March 28/29 2020:

- 1.Chief Routesetter
- 2.Routesetters (4)
- 3.Jury President
- 4.Head Judge

This event is an IFSC Olympic Combined format and will determine the Continental qualification quota for the Tokyo Olympics (1<sup>st</sup> placed male and 1<sup>st</sup> placed female competitors will be eligible for selection by their National Olympic Committees for Tokyo). Australia and New Zealand Federations will send a team each of 20 athletes (10 Male/10 Female) to this competition.

### Chief Routesetter and Routesetters

We are seeking one Chief Routesetter and 4 Routesetters. Chief will be responsible for the overall planning and building of all lead and boulder routes for the event. Routesetters will be required to build routes in both disciplines, though we will welcome applications from specialists on either lead or bouldering. We will be looking for both male and female setters from all Oceania Federations. Candidates from outside the Oceania region are also welcomed to apply.

All setters are required to work on March 25,26,27 building the routes and to also be in attendance at the event.

Travel expenses will be paid for by selected setters' Federations.

Candidates must show evidence of:

- 1.Ability to set at high level (lead 28+, bouldering v8+)
- 2.Established track record/formal qualifications of National setting for their Federation
- 3.Any other relevant experience
